The owner/operator shall retain this manual for future reference to important warnings, operating and maintenance instructions.

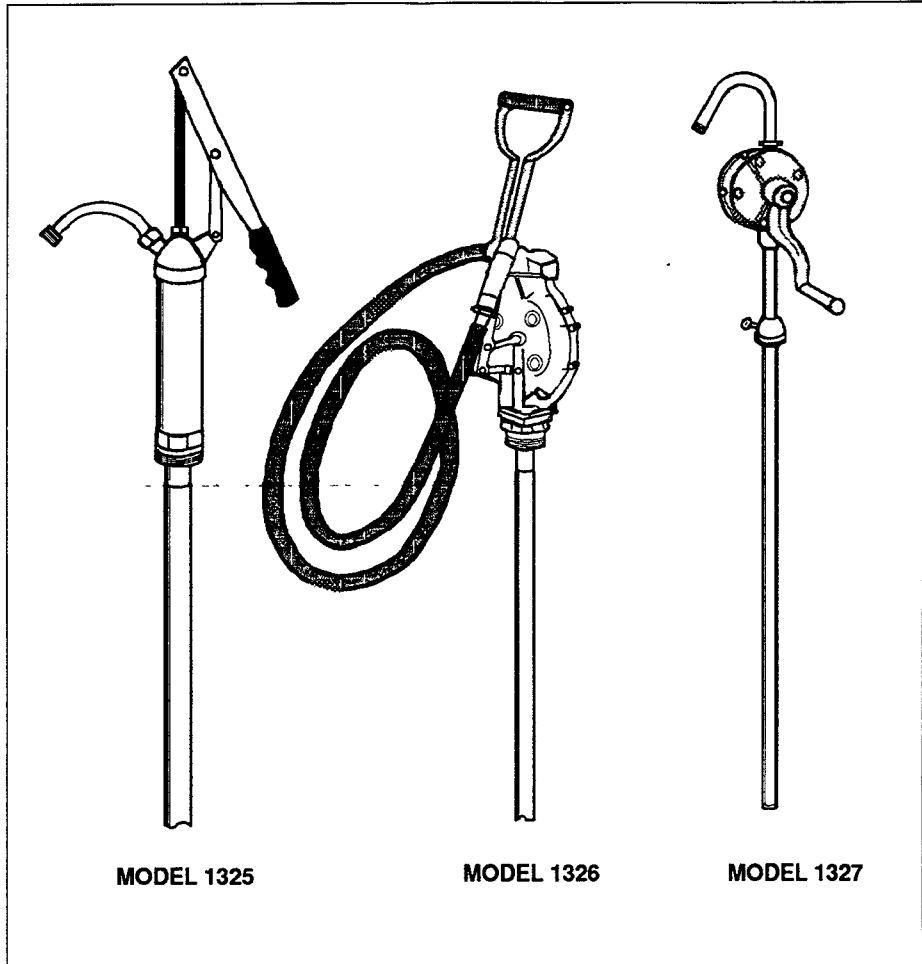
DESCRIPTION

The transfer pumps are designed to pump petroleum products as listed below. The pumps will fit 16 through 55 gallon drums with 2" bung openings.

Model 1325 is a lever action pump for pumping light liquid lubricants. The pump can dispense one pint per stroke. The pump has neoprene seals and a steel piston with brass piston rings for long life and durability. The discharge spout is curved with garden hose threads for convenient hose hookup and extension.

Model 1326 is a double acting diaphragm action pump for dispensing gasoline, diesel fuel and similar petroleum products. The double acting diaphragm delivers one full gallon per minute per eight strokes. An eight foot hose is provided for a long reach.

Model 1327 is a rotary/vane action

pump for dispensing gasoline, diesel fuel and similar petroleum products. The pump can deliver 7.5 gallons per 100 revolutions of the handle. The curved discharge spout has 3/4" NPT (Male) threads for ease of extension.

NOTE

The pumps are designed for use with non-corrosive petroleum based products of light to medium viscosity such as gasoline, fuel oil and motor oils. They should not be used with solvents, acids, alkalis, water or other corrosive liquids. **ANY PUMP SHOWING EVIDENCE OF RUST OR OTHER CORROSION DOES NOT QUALIFY FOR WARRANTY ADJUSTMENT.**

If equipment proves to be defective during this warranty period, it will be repaired or replaced without charge, provided that factory examination indicates the equipment to be defective. To obtain repair or replacement, it must be shipped, transportation charges prepaid, with proof of date of purchase to a Lincoln authorized Warranty and Service Center, within the one (1) year following the date of purchase.

This warranty is extended to the original retail purchaser only. This warranty does not apply to equipment damaged from accident, overload, abuse, misuse, negligence, faulty installation or abrasive or corrosive materials, or to equipment repaired or altered by anyone not authorized by Lincoln to repair or alter the equipment. This warranty applies only to equipment installed and operated according to the recommendations of Lincoln or its authorized field personnel. No other express warranty applies to lubrication equipment, materials dispensing equipment, and other related equipment manufactured by Lincoln.

ANY IMPLIED WARRANTIES applicable to lubrication equipment, materials dispensing equipment, and other related equipment manufactured by Lincoln INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WILL LAST ONLY FOR ONE (1) YEAR FROM THE DATE OF PURCHASE. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.
